COACH'S CODE OF CONDUCT

1. Coaches representing the Wisconsin Wrestling Federation in state, regional, national, and international events (including but not limited to training camps, developmental camps, and competitions) will conduct themselves in a proper and professional manner.
2. By agreeing to participate in WWF/USA Wrestling Events, coaches assume responsibility for the well being of the athletes participating in the event. It will be your responsibility to supervise the athletes, encourage proper behavior by all, ensure their well being and safety, and be a positive role model. Each coach is expected to display appropriate behavior and language while performing their assigned duties.
3. We as coaches are expected to follow the same code of conduct as we expect of our athletes when in their presence. In no instance shall alcohol be consumed or tobacco products be used in the presence of an athlete. When coaches are not in the presence the athletes, responsible adult behavior is expected at all times. Coaches are expected to be on time for all practices and able to perform and execute their coaching skills to the highest degree.
4. Coaches shall not participate in any illegal activity or encourage athletes to participate in any illegal activity.

I _____ have read and understand the Coach's Code of Conduct and agree to abide by the terms and conditions in this agreement. Failure to do so shall subject me to possible disciplinary actions, including suspension or termination of the privilege and rights associated with coaching within the WWF programs. The WWF Board of Directors shall have the right to fully investigate all failures in executing the above terms and conditions and impose further disciplinary action if deemed necessary.
